LAWSUIT UPDATE

In the Fall of 2007, the State filed a motion to dismiss. The GEIA and the Town of Charlton were part of that motion. A hearing was held in December 2007 at the Worcester Superior Court. The Court granted the motion to dismiss on 31 January 2008. Subsequently, Kevin and Debra Chambers have filed an appeal on 7 February 2008. REMINDER – BOATING SAFETY

Please remember to obey the speed limits on all parts of the lake and to use the boating channel through the narrows. Over the past few weeks, there have been several instances of boat(s) traveling at greater than headway speed after dark. Not only is this illegal under Mass boating laws, it is also very dangerous. The Glen Echo Lake boating courtesy rules are posted on the website. Please take a minute to download and review the rules and share them with every driver in your household.

The Narrows buoys have been installed along with the speed limit markers. Please stay within this channel at all times while traveling through the narrows. Remember these buoys delineate the boating channel from resident's swim areas.
